The project includes the installation of two ADA compliant Preschool bathrooms to an existing classroom. Services under this contract requires the contractor be a licensed Lead-safe Renovation Contractor and the contractor will furnish all labor, materials, tools, equipment and supervision necessary to accomplish the work described herein, accordance with all specifications and requirements including all permits and inspections. Prevailing wages apply. The construction is to occur over the summer when use of the facilities is minimal and timing is of the essence with all work completed on or near August 1, 2019. Bathrooms are to be turn-key upon completion.
